FIRST IPA WORLD FOOTBALL TOURNAMENT

Shkoder 04-08 June 2025







GENERAL PROVISIONS

Article 1.

The sports meetings of the first IPA World Football Tournament aim to encourage IPA members to get involved in sports life and continue the tradition of international communication. Their recognition and rapprochement through competition.

The gathering of IPA members in this tournament will be an excellent opportunity to familiarize them with the cultures of different countries, promote sports traditions, give members the opportunity to represent their country and improve the health of IPA members through sports matches.

It also promotes the international police association among young police officers and encourages them to join IPA.

ORGANIZATION OF THE MEETING

Article 2.

The entire course of the meeting is conducted and is the responsibility of the organization, which has this right and obligation determined by decision of the Organizing Committee.







Article 3.

The organization entrusted with the organization of the meeting performs part or all of the tasks related to providing the premises where the competitions will be held and hiring judges for matches and competitions.

Article 4.

Competitions in sports events are conducted by bodies that are formed immediately before the start of the competition and their selection is made by authorized representatives of the organizations participating in the event.

Article 5.

The organizing committee of the meeting shall provide all the necessary equipment for the competition (balls, playing fields, referees and all other match accessories)

Article 6.

The organizer is obliged to provide medical and health services during the meeting. In cases of injuries with more serious consequences, treatment continues in accordance with international health insurance, which is mandatory for every participant in sports games. The organizer has no obligations in this regard.

ORGANIZING COMMITTEE

Article 7.

Representatives of the organizing country form the Organizing Committee, which may also include representatives of other IPA Sections participating in the tournament, which has 5 members.

The function of the Organizing Committee begins on the day of its appointment by the organizer of the meeting and lasts until the closing of the meeting.







Verification of the performance of the duties of the Organizing Committee is carried out by the organizer of the games.

Article 8.

The Organizing Committee of the games elects the chairman, vice-chairman, secretary and honorary chairman of the meeting.

Article 9.

The Organizing Committee of the Games shall elect before the start of the competition: Competition Commission;

Disciplinary Commission;

Fair Play Commission;

Appeals Commission.

Article 10.

The Organizing Committee shall be responsible for:

Ensuring the regularity of the competition by fully implementing the regulations and rules for each discipline;

Deciding on requests for the protection of the regulations of the Games and the rules of the sports discipline;

Deciding on all other possible problems arising during the competition, unless another body is competent.

TOURNAMENT COMMISSION

Article 11.

The TOURNAMENT COMMISSION has 5 members and is the executive body of the Organizing Committee. The Competition Commission consists of the election of a president and a vice-president.

The TOURNAMENT COMMISSION is represented by 2 members from the Organizing Committee and 3 members from the organizers of the meeting, unless otherwise decided in a meeting before the start of the meeting by the representatives of the teams and the Organizing Committee.







COMPETENCES OF THE TOURNAMENT COMMISSION Article 12.

Ensures the proper implementation of the rules for the sports discipline represented in the tournament;

Determines the schedule and time of matches;

Inspects the facilities and grounds;

Organizes meetings with team managers;

Verifyes the tournament match minutes;

Provides interpretations of the Rules and regulations of the matches;

Decides on complaints in the first instance;

Prepares data on the course of the competition;

Evaluates the teams in the general ranking;

Resolves other issues related to the competition.

DISCIPLINARY COMMISSION

Article 13.

The Disciplinary Commission has 3 (three) members. During the election of the members, the president is also elected.

Article 14.

The Disciplinary Commission is responsible for:
ensuring the implementation of the provisions of these regulations;
deciding on the type and type of punishment;
ensuring the rules of the match that are not specified in the regulations.







APPEALS COMMISSION

Article 15.

The Appeals Commission has 3 (three) members. During the election of the commission, the president of the commission is also elected.

Article 16.

The commission is responsible for deciding in the first instance on the complaints of the teams, exclusively on the arbitration, or material violation of the rules committed by the referee during the competition, applicable to that sports discipline.

COMPLAINT RESOLVING

Article 17.

The Commission shall decide on complaints on the day of the complaint and shall decide within 90 minutes after the complaint is filed.

Article 18.

Following the referee's report on an excluded competitor or a dismissed team leader, the Disciplinary Commission shall decide on the basis of the facts set out in the minutes. It shall decide on the hearing session and the taking of statements.

Article 19.

The complaint shall be filed within 15 minutes after the competition has been held and shall be announced during the compilation of the minutes of the competition held.

FAIR PLAY COMMISSION

Article 20.

The Fair Play Commission shall consist of 3 (three) members. When the Commission is elected, the President of the Commission shall also be elected.

Article 21.

After the competition, all judges shall draw up a list of the proposed teams ranked from 1 to 3 most successful in fair play. These lists shall be submitted to the Fair Play Commission,







which shall determine the team that shall be the winner of fair play in the games based on them.

These lists shall be submitted to the Fair Play Commission, which shall determine the team that shall be the winner of fair play in the matches based on them.

RIGHT TO PARTICIPATE IN THE TOURNAMENT

Article 22.

All IPA World members may participate in the TOURNAMENT.

An IPA member may register more than one team but under a different name.

Article 23.

The application for participation is made on the application form provided by the organizer.

The application must contain:

the name of the Organization applying;

the sports disciplines in which it wishes to compete;

the total number of participants who will be in the tournament (no more than 12 people).

Article 24.

The application is submitted to the address of the Organizer of the games 45 days before the start of the tournament, and in exceptional cases no later than 10 days before the start of the meeting.

Article 25.

Organizations that meet the requirements of Articles 23 to 24 of these Rules may participate in the Tournament.

Article 26.

Each participant in the Games shall voluntarily assume any risk or consequences arising from the matches in which the competitors participate.







SPORTS DISCIPLINES REPRESENTED IN THE TOURNAMENT

Article 28.

In order for the competitor to be able to compete for his team, the team leader is obliged to report the participant's surname and first name to the official before the competition.

Article 29.

The competition is held according to the rules established for the football tournament.

Article 30.

The tournament is held in accordance with the provisions of the Rules and Proposals approved by the Organizing Committee.

ACTIVITY CONDUCT

Article 31.

The competition in the games will be held in accordance with Article 30 of the Rules and Regulations.

Article 32.

The tournament will be held according to the cup or points system, depending on the number of registered participants.

Article 33.

In order to be able to compete for the team for which he is registered, each competitor in the games must prove his/her identity with an IPA identity card with a photograph, and is obliged to show it if the Organizing Committee requests it.







Article 34.

A football player may only play in the team for which he/she is registered and has played the first match of the tournament

Article 35.

A team that does not arrive at the scheduled start time of the match will be waited for 15 minutes. After this time, the team loses the right to participate in that match, and the result will be recorded in accordance with the rules for that discipline.

The overall placing of the teams is determined based on the sum of points earned in the matches played

Article 36.

A complaint regarding the result must be submitted in writing to the Organizing Committee within 60 minutes after the match result has been published on the game notice board.

Article 37.

The organizer will provide the participants in the tournament with cups and diplomas, which will be awarded for team and individual results, as well as for FAIR PLAY.

- a. For the results achieved in the team ranking, for the first place, a cup and diploma and individual medals; for the second place, a cup and diploma and individual medals
- b. For the results achieved in the individual sports performance, the following special awards will also be awarded:
- 1-For the best goal scorer of the tournament, the GOLDEN SHOES award will be given.
- 2-For the best striker of the tournament will be awarded a SPECIAL CUP
- "Medin SHEGA"
- 3-For the best midfielder of the tournament will be awarded a SPECIAL CUP
- "Ramazan RRAGAMI"







- 4-For the best defensive midfielder of the tournament will be awarded a SPECIAL CUP
- " Sabah BIZI"
- 5- For the best goalkeeper of the tournament will be awarded a SPECIAL CUP
- " Paulin NDOJA"
- 6- For the friendliest athlete of the tournament will be awarded a SPECIAL CUP
- " HYSNI BEBEZIQI"
- 7-For the youngest athlete of the tournament will be awarded a SPECIAL CUP
- "Youngest athlete of the tournament"
- 8- For the oldest athlete of the tournament will be awarded a SPECIAL CUP
- "Oldest athlete of the tournament"
- 9- For the best coach of the tournament will be awarded a SPECIAL CUP
- "Loro BORICI"
- 10- For the best doctor of the tournament will to be awarded the SPECIAL CUP
- "Zyhdi COBA"
- 11- For the best referee of the tournament the SPECIAL CUP
- "Qazim DERVISHI"
- c. The Organizing Committee will also award the TEAM FAIR PLAY award and a Cup for each participating team

Article 38

The Fair Play Cup is awarded by the Organizing Committee upon the proposal of the Fair Play Commission at the closing ceremony of the Games.

COURTS AND JUDGING IN GAMES

Article 39.

The judges for judging the tournament matches will be provided by the organizer.

RESOLVING DISPUTES ARISING DURING THE COMPETITION

Article 40.

Disputes arising during the tournament shall be resolved in accordance with the provisions of the proposals and regulations by the appeal committee, the disciplinary committee and the competition committee.







Article 41.

The punitive measures against participants specified in these Regulations shall not be taken by decision, but shall be applied directly when the specified case occurs.

Article 42.

A sportsman excluded by decision of the referee shall not have the right to play in the same match and the subsequent match.

FINAL PROVISIONS

Article 43.

These Regulations shall be approved by the Organizing Committee by majority vote.

Article 44.

These Regulations may be amended and supplemented by the same procedure as their approval.

Article 45.

These Regulations shall enter into force on the date of their approval.
